Sub: Application of S. M. Deo Homocopathic Medical College and Hospital, Sardar Patel Campus Gaykhuri, Balaghat, Madhya Pradesh - 481001 for permission with intake capacity of 50 seats in BHMS course for A.Y. 2024-25 under section 29 of NCH Act 2020 – regarding.

Sir.

S.M. Deo Homoeopathic Medical College and Hospital, Madhya Pradesh has submitted an application for permission for sanction of 50 seats in BHMS course for the academic year 2024-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARBH has conducted Inspection on 26.07.2024 and 27.07.2024 and few shortfalls have been observed. MARB has examined the profile of the College as to whether the college fulfils the Minimum Standard requirements to be fulfilled as per the prevailing regulations under NCH Act 2020. As per the shortfalls made by MARBH, following lacunae are to be rectified with immediate effect. College shall fulfil all functional requirements as per the Minimum Standard requirements.

- 1. Only one sanitation staff available for college and Hospital.
- 2. Store register not properly maintained.
- 3. College shall subscribe National and International Journal in the library
- 4. Biometric attendance available without entry and exit time. AEBAS shall be implemented within a period of 01 month.
- 5. Form-16 not provided from TRACES portal. Same shall be provided.

Considering the above observations, and facilities available, MARBH has decided to issue conditional permission to S. M. Deo Homocopathic Medical College and Hospital, Sardar Patel Campus Gaykhuri, Balaghat, Madhya Pradesh - 481001 for permission with intake capacity of 50 seats in BHMS course for A.Y. 2024-25.

The shortfalls observed in your College shall be rectified within a period of 30 days or before the first day of counselling for admissions, whichever is earlier failing which conditional permission will be withdrawn without prior notice.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by the Central Government and counselling for the remaining 85 % seats or as the case may be, shall be

conducted by the concerned counselling authority of the state/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the MARBH after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by MARBH
